Other factors that may affect payment include medical record documentation, legislative or regulatory mandates, a provider's contract, a member's eligibility in receiving covered services, submission of clean claims, other health plan policies, and other relevant factors. These factors may supplement, modify, or in some cases supersede reimbursement policies.*

## Reimbursement Guidelines

Davis Vision is the benefits administrator for routine eye care services for Keystone First – CHIP. Routine examinations are covered services and therefore eligible for reimbursement by for certain members each calendar year. Members under 19 are eligible for two pair of prescription eyeglasses OR two sets of contact

lenses every 12 months. Keystone First - CHIP does not cover prescription eyeglasses or prescription contact lenses for members 19 years of age and older.

Eye Exams	2 routine eye exam every calendar year
Eyeglasses* (frames) (V2020)	2 pair of in plan selection eyeglass frames every 12 months up to (insert dollar allowance if applicable
Lenses*	2 pair of standard lenses every 12 months
Contact Lenses	1 set of contact lenses are allowed each year

Extended ophthalmoscopy with a retinal/optic nerve drawing, (unilateral or bilateral) (92201-92202) is non-covered when billed with fundus photography (92250) or a with fluorescein angiography (92235).

An extended ophthalmoscopy with a retinal/optic nerve drawing, (unilateral or bilateral) will not be reimbursed without a diagnosis of disorders of the globe, choroid, retina, iris and ciliary body, or glaucoma.

### **Lenses**

Reimbursement of V2100 (sphere, single vision, plano to plus or minus 4.00, per lens) and V2101 (sphere, single vision, plus or minus 4.12 to plus or minus 7.00D, per lens), is limited to once in a 12-month period.

### **Contacts**

Members may choose prescription contact lenses instead of glasses. Polymethyl methacrylate, spherical rigid lenses (V2500) are limited to twice in a 12-month period.

All claims for routine vision care must be submitted to Davis Vision for reimbursement. Medical treatment of eye disease is covered directly by Keystone First - CHIP.

## **Definitions**

### **Extended ophthalmoscopy**

The method of examining the posterior portion of the eye when the level of examination requires a complete view of the back of the eye and documentation is greater than that required during routine ophthalmoscopy.
